In 2022 and 2023, the company was proud to announce that several of its dealerships had been recognized as J.D. Power Dealers of Excellence, on the basis of their ability to deliver efficient, transparent and customer-friendly sales experiences. Dilawri was also a 2023 winner of the Canada's Best Managed Companies program, which recognizes excellence in private Canadian-owned companies.

Dilawri is proud to offer exceptional products and services, delivered by our more than 3,500 employees. We are committed to leadership in business as well as in the communities we serve. Since 2002, the Dilawri Foundation has contributed millions of dollars to a wide range of charitable causes.

2. Risks of Forced or Child Labour in our Business and Supply Chains

Navigating Supply Chain Risks with Diligence and Integrity

At Dilawri, our operations span across Canada, a country recognized for its commitment to human rights and stringent regulatory frameworks. This geographical footprint, according to insights from the Walk Free Foundation's Global Slavery Index 2023, situates us in areas considered to be among the lowest risk for practices of forced and child labor due to robust legal protections and oversight.

Proactive Risk Management in a Global Context

Despite the low-risk environment of our primary operations, we are not complacent. We understand that the automotive industry, characterized by its global reach and complex supply chains, presents inherent challenges. Our portfolio, featuring 38 of the world's leading automotive brands, involves intricate supply arrangements with original equipment manufacturers (OEMs) - esteemed multinational entities known for their rigorous governance and business ethics.

However, the automotive sector is not immune to the risks associated with modern slavery, especially in parts of the supply chain that extend into regions with varying levels of regulatory enforcement and human rights protections. We invite interested parties to look at the OEM's own reports for further information on their efforts to address risks in their supply chains.

At Dilawri, our commitment to excellence extends beyond our products and services to embody the highest standards of ethical conduct and social responsibility. Recognizing the critical importance of safeguarding human rights within our operations and supply chains, we are actively developing a comprehensive framework to identify, assess, and manage risks related to forced and child labor.

3. Measures to Remediate Forced or Child Labour

While Dilawri has not identified instances of forced or child labor within our supply chain or identified risks necessitating remediation measures for the loss of income to vulnerable families to date, we remain vigilant. Our approach is not static; it evolves with our ongoing commitment to ethical practices and corporate governance. We are in the process of developing and implementing strategies to assess and mitigate potential risks more effectively. These strategies include:

• Supplier Engagement and Education: Collaborating with our suppliers to reinforce the importance of transparency and ethical labor practices.

- Continuous Monitoring and Assessment: Establishing mechanisms for regular review and assessment of our supply chain, ensuring alignment with our ethical standards.
- Stakeholder Collaboration: Seeking opportunities to work with industry groups, NGOs, and other stakeholders to share knowledge and best practices in combating modern slavery.

Dilawri's journey towards ensuring a supply chain free of forced and child labor is guided by our core values of integrity, excellence, and responsibility. We are dedicated to making informed, ethical decisions that reflect our commitment to being a leader in the automotive industry and the communities we serve.

4. Policies & Processes

Dilawri is committed to comprehensive employee training programs, though specific training on forced and child labor is in the planning stages.

5. Approval
