Fighting Against Forced Labour and Child Labour in Supply Chains Act for the Fiscal Year 2023

This joint statement is made pursuant to Canada's Bill S-211, An Act to enact the Fighting Against Forced Labour and Child Labour in Supply Chains Act and to amend the Customs Tariff.

This statement outlines the approach and initiatives by Abatement Technologies Limited, and the foreign wholly owned entity Abatement Technologies, Inc. to identify and address the risks of forced labour and child labour in its business operations and supply chains during the fiscal year commencing January 1st, 2023 and ending December 31st, 2023.

We recognize our responsibility to respect and protect the human rights of all people who support and interconnect with our business. Abatement Technologies' commitment to prevent and reduce the risk of forced and child labour applies to our entire organization, our business partners and our worldwide supply chain network. We expect our suppliers (as well as their suppliers, agents and labour) to uphold these same principles within their operations and adhere to applicable human rights and employment laws.

Our Policies and Due Diligence Process

- Abatement Technologies has a Supplier Code of Conduct that must be followed by all of its suppliers which calls out the importance of respecting human rights
- Abatement Technologies has an Employee Code of Conduct that must be followed by all of its employee's
- Abatement Technologies conducted a risk assessment of its supply chain
- Abatement Technologies performed a supply chain mapping exercise
- Developed and implemented awareness materials on forced labour and child labour

Assessing our Effectiveness

Abatement Technologies intends to continue to assess, refine and improve key performance indicators to measure our success in our commitment to fighting against forced labour and child labour in our supply chains.

We conduct ongoing screening of all suppliers, which allow a baseline to a supplier's risk profile and subsequently flag any activities that would violate our Supplier Code of Conduct. Using these methods along with monitoring procedures, policies and processes, no evidence of modern slavery – including forced labour or child labour have been identified in 2023 and thus has not been a basis to take remedial actions regarding such matters.
