Our History

What started out as small little company in a shop on an acreage, quickly grew and by 2013 work began on a new automated processing plant 6 kilometers south of Fort Macleod, Alberta, Canada.

Since that day, the Arjazon family has been proudly growing into a worldwide company. We specialize in the cleaning, processing and packaging of more than 18 products locally sourced from our valued producers in Saskatchewan, Manitoba, Montana and right here in Alberta. Including exporting more than 55,000 Metric Tons a year to over 120 destinations around the globe.

The Arjazon Family prides itself on making integrity, honesty and fairness a priority with our valued clients, producers and suppliers.

Our Bison Brand

At the end of 2018 one of our international clients requested their product be packaged and shipped in neutral branded bags that would still stand out on shelves. So, a creative employee freehandedly drew out what become the first two white and green Bison Branded bag designs. The release of the first 2,000 bags, went on to open up all new international markets for Arjazon Seed Trading. Then by the end of 2022, popularity for our Bison Branded bags had increased so much, clients were requesting a more colorful design, so their product could stand out from the rest.

So, by early 2023, work began on a completely new and colorful design while also incorporating the original hand drawn design, giving us the beautiful new Bison Branded bags we use today.

Our Facility

The Arjazon facility contains two fully automated processing lines, which include an advanced X-Ray sorter and optical sorters with infrared cameras, to eliminate impurities from the raw product that cannot be otherwise detected. The flexibility of the processing lines allows us to clean, process and package a large variety of products to meet each of our client's quality specification requirements.

Arjazon's facility is regularly audited by local and international governing bodies to ensure it surpasses the standards of all its certifiers. We are proudly in full compliance with the SQF Food Safety Standards, Canadian Organics, Kosher, the Canadian Food Inspection Agency and all HACCP standards.

Our Suppliers

We are proud to be partnered with our highly valued producers and suppliers who ethically source us only the finest products for our export clients. Our primary suppliers are our producers from Manitoba, Saskatchewan, Montana and Alberta whose crops we purchase for product to clean, process and package. We also have suppliers who provide us with the bags that match our clients' specifications, but these suppliers are all Canadian companies as well and are believed to have no risk of forced or child labour in Canada.

Our Commitment and Policies

Our Human Rights Policy

Arjazon Seed Trading is committed to upholding the principles of human rights as outlined in the Alberta Human Rights Act and other applicable legislation. We believe in creating and maintaining a workplace environment where all employees, contractors, clients, and visitors are treated with dignity and respect, regardless of their race, ethnicity, religion, gender sexual orientation, age, disability, or any other characteristic protected by law. Arjazon Seed Trading is an equal opportunity employer. We do not discriminate in hiring, promotion, compensation, or any other aspect of employment based on protected characteristics. Any updates or revisions will be communicated to employees in a timely manner.

Supplier Code



As a valued supplier to our company, we expect our partners to share our commitment to ethical conduct, sustainable practices, and adherence to applicable laws and regulations.
