

This report was made pursuant to Bill S-211, an Act to enact the fight against Forced Labor and Child Labor in supply chain acts. This joint statement outlines the approach and initiatives of Diversco Supply Inc. (875144628) and DyTerra Corporation (863089728). Although we had not yet implemented forced labor and child labor into our supply chain, our fiscal period, January 1 – December 31, 2023, we initiated the analysis of our internal processes and policies to develop and implement strategies for future integration and ongoing process improvement. As we embrace transparency, accountability, and collaboration, we are focused on setting a standard for responsible ethical business conduct.

Diversco is a leading importer and distributor of a wide range of products across a few companies, and several diverse divisions. With a strong focus on quality, reliability, and sustainability, Diversco has established itself as a trusted partner for businesses in various industries. Some of the company's divisions include Propane and Natural Gas Equipment, Scuba Diving, Watersports, Marine Products, Compressed Gas Equipment, and Anhydrous Ammonia Equipment. By importing high-quality goods primarily from the United States, Europe, and Asia, Diversco caters to the needs of businesses across North America.

Diversco operates with a centralized organizational structure to efficiently manage its diverse product portfolio and serve its varied customer base. The company's structure consists of seven divisions, each overseen by a dedicated team of professionals with expertise in their respective fields. These divisions operate semi-autonomously but share departmental services to ensure synergy and coherence across the organization.

Diversco operates a robust supply chain to ensure the timely and efficient importation, warehousing, and distribution of its products. The company's supply chain encompasses various stages, from sourcing and procurement to warehousing and delivery, with a focus on quality control, reliability, and sustainability.

The company sources its products from reputable manufacturers and suppliers in the United States, Europe, and Asia. For the Propane and Natural Gas Equipment Division, Compressed Gas Equipment Division, and Anhydrous Ammonia Division, Diversco/DyTerra primarily collaborates with manufacturers in the United States known for their expertise and adherence to industry standards.

Diversco maintains strategically located warehouses across the United States and Canada to optimize its distribution network and serve its customer base efficiently. With eight warehouse locations strategically positioned to minimize transit times and reduce shipping costs, the company ensures prompt delivery of orders to its B2B customers. Each warehouse is equipped with state-of-the-art facilities and employs dedicated staff to manage inventory, process orders, and coordinate shipments.

Diversco primarily sells its products through business-to-business (B2B) channels, catering to retailers, wholesalers, and industrial customers across North America. The company maintains strong relationships with its distribution partners and sales representatives, who play a crucial role in promoting its products and providing support to customers. Additionally, Diversco leverages e-commerce platforms and digital marketing channels to reach a broader audience and facilitate online sales.

At Diversco we ensure all senior executive levels manage policy, procedures, and vendor management. President and Vice President of Operations at DyTerra, along with the President of Operations and General Manager at Diversco. Human Resources for Diversco and DyTerra effectively manage onboarding for their respective units, with training and development under the management of the Director of Sales and each divisions respective managers.

Our company upholds a mandatory Code of Business Conduct for all employees to ensure full compliance with our guidelines. This code outlines the expected behavior and ethical standards that each employee must adhere to in their professional conduct. Additionally, we have implemented an "open door" policy to provide a transparent and accessible process for conflict resolution. This

policy encourages employees to raise any concerns or conflicts they may encounter in a safe and supportive environment, allowing for timely and effective resolution.

In 2023, in preparation of Forced Labor and Child Labor legislation we reviewed all policies and procedures as well as the referenced Business Code of Conduct to effectively implement and bring awareness to the revised policies. In conjunction to the internal policy reviews, we had designed and engineered a Vendor Procurement Policy and Guideline, which incorporates communications, reviews, and compliance enforcement. This will be beneficial for our future vendor partnerships to mitigate forced labor and child labor within our supply chain. We have not identified any forced labor or child labor in our activities or supply chain, nor any remediation measures required.

At Diversco Supply Inc. and DyTerra Corporation, we remain committed to ethical sourcing and supply chain integrity. We are confident that as we move towards minimizing risks associated to forced labor and child labor, with the implementation of the 2023 designed policies and procedures and our continuous improvement initiatives will be successful in preventing the scourge of forced labor and child labor from infiltrating our supply chain.

While we are proud of our philanthropic activities and will continue to strive towards ethical conduct in our work environment, business practices and relationships with all external stakeholders.
