

Revised Report by Kansai Paint Co., Ltd. and Kansai Paint Canada, Ltd.

This is the revised joint report under Fighting Against Forced Labour and Child Labour in Supply Chains Act (S.C. 2023, c. 9) (“Act”) for the financial reporting year starting from April 1, 2023 and ending on March 31, 2024 of Kansai Paint Co., Ltd. and for the financial reporting year starting from January 1, 2023 and ending on December 31, 2023 of Kansai Paint Canada, Ltd.

This report covers Kansai Paint Co., Ltd., a Japanese corporation, and its subsidiary, Kansai Paint Canada, Ltd., a Canadian corporation.

Neither company is subject to reporting requirements under supply chain legislation in another jurisdiction.

Kansai Paint Co., Ltd. and Kansai Paint Canada, Ltd. hereby report as follows:

(a) its structure, activities and supply chains;

Kansai Paint Co., Ltd. and its subsidiary, Kansai Paint Canada, Ltd., are directly and indirectly engaged in import into Canada of paint products produced outside Canada and distribute them in Canada.

(b) its policies and its due diligence processes in relation to forced labour and child labour;

In relation to forced labour and child labour, Kansai Paint Co., Ltd. has a human-right policy and the reporting entities will create a mechanism for human rights due diligence to ensure that the reporting entities identify negative impacts from the reporting entities' business activities on human rights and strive to prevent and mitigate their occurrence.

(c) the parts of its business and supply chains that carry a risk of forced labour or child labour being used and the steps it has taken to assess and manage that risk;

Neither entity can assess or manage the risk of forced labour or child labour being used in its business or supply chains as neither entity has taken steps to assess and manage that risk.

(d) any measures taken to remediate any forced labour or child labour;

Neither entity on this report has taken measures to remediate forced labour and child labour.

(e) any measures taken to remediate the loss of income to the most vulnerable families that results from any measure taken to eliminate the use of forced labour or child labour in its activities and supply chains;

Neither entity on this report has taken measures to remediate the loss of income to the most vulnerable families that results from any measure taken to eliminate the use of forced labour or child labour in its activities and supply chains.

(f) the training provided to employees on forced labour and child labour; and

Neither entity has provided the training to employees on forced labour and child labour.


(g) how the entity assesses its effectiveness in ensuring that forced labour and child labour are not being used in its business and supply chains.
