
The majority of our goods are purchased from local suppliers, see Chart 1

Policies & Due Diligence

Kenpal has a supplier approval program in place, in which a list of approved suppliers is created. We then ask that all suppliers complete our supplier questionnaire.

Kenpal maintains product approval files for any ingredients that might be used in our end product. Part of this process is to request a certificate of origin for all ingredients, which shows the country of origin for all ingredients.

Kenpal requests updated certificates of origins every year to maintain our traceability.

Risk Assessment

Kenpal's greatest risk to forced labour and child labour is through suppliers purchasing from high-risk countries. Based on the breakout by country, the majority of our ingredients purchased are not from high-risk countries.

Currently we do not request any information on what policies or procedures our suppliers have in place with regards to forced and child labour as all our direct suppliers are located in Canada and the US.

Remediation Measures

When looking at the risks of forced labour and child labour in our supply chain through the risk assessment, we did not implement any remediation measures, due to the lower prevalence of these activities in the countries we purchase the majority of our ingredients from.

Assessing Effectiveness

Kenpal is committed to understanding our supply chain through our supplier and ingredient approval process. We will evaluate our supplier approval questionnaire to see if we can evaluate the risk of forced labour and child labour during that process.

Training

Kenpal will review adding components of forced labour and child labour into our training programs for our supplier approval process, and those involved in the procurement process.
