Focusing on regions with a vulnerability score exceeding 40 to modern slavery, our assessment revealed that a significant portion of our suppliers operate in higher-risk countries. Leveraging insights from the G20 imports Codebook and the Harmonized System Codes Directory, we identified specific products susceptible to risk originating from these regions.

We are pleased to report that, following a meticulous review, our products demonstrate no risk of modern slavery according to the standards outlined in the Slavery Index Codebook. This reaffirms Mevotech's dedication to upholding the highest standards of integrity and human rights within our supply chain.

Through proactive risk assessment and transparent communication, Mevotech sets a precedent for responsible business conduct, inspiring trust, and confidence among



stakeholders. We remain steadfast in our commitment to promoting ethical sourcing practices and driving positive change within our industry.
