Supply Chains Act

Introduction

This report is made on behalf of Molesworth Farm Supply Ltd ("Company" or "MFS") and describes the actions taken by the Company during the financial year ending September 30, 2023 to assess, prevent and reduce the risk that forced labour or child labour is used at any step in its operations and supply chains pursuant to the requirements of section 11 of the Fighting Against Forced Labour and Child Labour in Supply Chains Act ("Act"). This Report constitutes the first report prepared by the Company under the Act.

Structure, Activities and Supply Chains

The Company is a corporation based in Molesworth, Ontario. Company operates two manufacturing facilities and administration office at this location.

The Company specializes in the manufacturing and distribution of feed products mainly for the swine production industry. The Company's philosophy is simple; to make the best meal & pelleted feeds available in the market, and by extension assist our customers in being successful in their business.

The majority of the Company's procurement spend is for raw materials used in the feed milling process. The principal raw materials used are grains (corn, soymeal, wheat, barley), dairy products, oils, and other agricultural products. The majority of the Company's supply chain raw materials are purchased from local farmers and Tier 2 suppliers located in Canada. Inputs that are not locally available may be imported from other countries (Tier 2 suppliers).

The Company also purchases goods and services from other third-party suppliers. These goods and services include diesel fuel, repairs & maintenance (parts & labour), utilities and office supplies. Majority of these suppliers are located in Canada.

Policies and Due Diligence Processes

The Company has drafted a questionnaire for vendors.

Assessment of Forced Labour and Child Labour Risks

The Company has not independently engaged in its own risk assessment with regards to forced labour or child labour in its supply chain. As the majority of the Company's supply chain is local farms, we believe there are minimal risks.

Remediation Measures

The Company has not identified any instances of forced labour or child labour in its supply chain, and so no remediation measures have been taken.

Training

The Company has provided training for key personnel on forced labour and child labour in supply chain.

Assessing Effectiveness

The Company has not taken any action to assess its effectiveness in addressing risks of forced labour and child labour in its activities and supply chains.
