Nanaimo Forest Products LTD is a privately owned corporation that does business in Nanaimo, British Columbia, Canada.

- (b) importing into Canada goods produced outside of Canada.

#### A. Structure, Activities and Supply Chains;

#### (i) Structure:

Structure: Privately held Corporation - incorporated in the Province of British Columbia.

Nanaimo Forest Products LTD has approximately 350 employees and operates exclusively at one facility in Nanaimo British Columbia, Canada.

Nanaimo Forest Products LTD has a Board of Directors who provides oversight to the General Manager/CEO for the purposes of business operations. The General Manager/CEO directly supervises the Financial Manager/CFO, the Fibre Manager, the Human Resources Superintendent, the Engineering and Maintenance Manager, the Steam Plant Superintendent, the Information Technology Manager, the Technical Services Superintendent and the Production Superintendent.

#### (ii) Activities

NBSK Pulp Producer with sales in Canada, United States, Europe, Australia and Asia.

Green Power Producer for exclusive power sales under an Energy Purchase Agreement with British Columbia Hydro.

Other business ventures including a limited partner with a propane terminal, future Hydrogen Fuel business (in development phase) and industrial land holder for I4 zoned future business opportunities.

Nanaimo Forest Products LTD ensures all products sourced are from law abiding suppliers and ensures all products meet the specified requirements included on the purchase orders issued.

#### B. Policy and due diligence processes in relation to forced labour and child labour;

Nanaimo Forest Products LTD reviews all providers of goods and services on a regular basis and depending on the product and the source country, deems the provider on a scale of Low, Medium or High risk. Each rating has increasingly higher review standards to ensure sources meet Nanaimo Forest Products LTD requirements. During the fiscal year ended July 31, 2023, all suppliers were deemed to be in the Low risk category.

Nanaimo Forest Products LTD will be instituting a policy that requires all future purchase orders to have a reference to the Act S-211 to ensure vendors are aware of our commitment to ensuring the reduction and elimination of forced labour and child labour.

Nanaimo Forest Products LTD will also formalize in policy the risk rating system for vendors and purchasing protocols for each rating for the year ended July 31, 2024.

### C. Parts of the business and supply chains that carry a risk of forced labour or child labour being used and the steps taken to assess and manage that risk;

Nanaimo Forest Products LTD has approximately 3000 vendors from which it has purchased goods or services from in the past decade. From the list, Nanaimo Forest Products LTD determined that approximately 99.76% of the listed vendors are based in Canada or the United States or were not used in fiscal 2023. After review of the 2022 List of Goods produced by Child Labor or Forced labour, published in the Bureau of International Labour Affairs on the US Department of Labor website, (List of Goods Produced by Child Labor or Forced Labor | U.S. Department of Labor (dol.gov)), all vendors from both Canada and United States were deemed extremely low risk. Of the remaining vendors based outside of the Canada and the US, Nanaimo Forest Products LTD. used only seven vendors who are based in the following European Countries in fiscal 2023 as follows:

- (i) Two vendors in Germany that provided NBSK pulp testing services for food contact certification.
- (ii) Two vendors in United Kingdom One that provides a monthly news and analysis of the international pulp market and the second provide a proprietary part for manufacturing equipment used on site.
- (iii) One vendor in Finland that provided equipment and installation support for a large mechanical machine;
- (iv)One vendor in Denmark that provided evaluation and optimization consulting services for software used on site.
- (v) One vendor in Sweden provides pulp marketing services

Nanaimo Forest Products LTD deems all vendors used outside Canada and the US to be at extremely low risk of the use of forced labour or child labour based on the

All appropriate personnel involved in supply chain procurement will be reminded of the urgency and necessity of ensuring Nanaimo Forest Products LTD is committed to the reduction and elimination of Forced Labour and Child Labour for upcoming fiscal years.
