Oracle Canada ULC, and Oracle Canada Development Company ( "Oracle Canadian Entities" ) are affiliates of Oracle Corporation, and are incorporated in Alberta and Nova Scotia, respectively. Oracle Canada ULC' s registered office location is 7 Avenue SW, Calgary, AB T2P 4KP, Canada. Oracle Canada Development Company' s registered office location is 1741 Lower Street, Suite 600, Halifax, NS, B3J OJ2, Canada.

The Directors and Management of Oracle Canadian Entities are fully committed to a work environment and supply chain that is free from forced labour and child labour. Oracle will not tolerate or condone forced labour and child labour in any part of our global organization. It is for this reason that the 2023 Oracle Statement Against Modern Slavery ( "Modern Slavery Statement" ) (<https://www.oracle.com/a/ocom/docs/corporate/citizenship/statement-modern-slavery.pdf> ) covering financial year 1 June 2022 to 31 May 2023 is approved by the Oracle Canadian Entities for the purposes of reporting under the Fighting Against Forced Labour and Child Labour in Supply Chains Act.

Oracle has no hardware manufacturing sites in Canada. Oracle does not have any managed hardware suppliers producing Oracle products or components in Canada.

Oracle has not identified any loss of income to the most vulnerable families and therefore has not taken measures to remediate any possible loss of income to the most vulnerable families due to steps Oracle has taken to eliminate forced or child labor risks in Oracle' s activities and supply chains.

It is the belief of the Directors and Management of the Oracle Canadian Entities that the measures described in the 2023 Oracle Statement Against Modern Slavery are consistent with our core values to protect and advance human dignity and human rights, and prevent forced labour and child labour in our global business practices and supply chains. 
