

# SOURCE ROCK ROYALTIES LTD.

## Report on Measures to Prevent and Reduce the Risk of Forced and Child Labour in Supply Chains

### I. INTRODUCTION

This is the first report of Source Rock Royalties Ltd. (“**Source Rock**”) under the *Fighting Against Forced Labour and Child Labour in Supply Chains Act* (the “**Act**”). This report relates to Source Rock’s 2023 financial reporting period from January 1, 2023 to December 31, 2023. Source Rock supports the objectives of the Act and is committed to supporting and implementing responsible and sustainable business practices. We are bound by and implement in Canada the policies and standards of business ethics and sustainability of the Act, including as they relate to respect for human rights and the fight against all forms of modern slavery. This report sets out the information required by Act.

### II. SOURCE ROCK STRUCTURE, ACTIVITIES AND SUPPLY CHAIN

#### a. Structure and Activities

- Incorporated pursuant to the Business Corporations Act (Alberta).
- Based in Calgary, Alberta.
- Listed on the TSX Venture Exchange.
- Oil & Natural Gas Industry.
- An indirect beneficiary from the production, extraction and sale of petroleum, natural gas and natural gas liquids through the ownership of royalty interests.

#### b. Supply Chain

Source Rock does not have a supply chain relating to the production, extraction and sale of goods. As an owner of royalty interests in oil and gas mineral rights, Source Rock receives revenue from the operators of its royalty lands when they produce and extract petroleum, natural gas and natural gas liquids. The operators of Source Rock’s royalty lands control the operations and processes, and therefore the supply chain, to produce, extract and sell products from the royalty lands.

### **III. POLICIES AND PROCEDURES IN RELATION TO FORCED AND CHILD LABOUR**

Given Source Rock does not have a supply chain, it does not implement any policies and procedures in relation to forced and child labour. All of Source Rock's royalty payors are Canadian based. Source Rock believes that the majority of its royalty payors are considered to be an "entity" pursuant to the Act. These royalty payors are in complete control of and manage the supply chain for the extraction, processing and sale of products from the lands in which Source Rock owns royalty interests.

### **IV. RISK ASSESSMENT, DUE DILIGENCE, MANAGEMENT AND MITIGATION**

As Source Rock does not have a supply chain for the production, extraction, processing and sale of products from its royalty lands, it does not undertake formal risk assessment, management and mitigation efforts relating to forced and child labour. Source Rock is focused on owning royalty interests in lands located in Canada and that are operated by reputable Canadian-based producers.

### **VI. REMEDIATION MEASURES**

Source Rock does not have a supply chain relating to its business and therefore has not identified any incidents of forced or child labour. As such, Sourced Rock has not taken any related remediation measures and, therefore, has not taken any steps to mitigate any negative effects on vulnerable families of remediation measures.

### **VII. TRAINING**

Source Rock has one full-time employee and does not engage any consultants relating to the production, extraction, processing and sale of products. Given Source Rock's lack of operational activities, and therefore not having a supply chain, it does not provide training relating to the prevention and reduction of risks associated with forced and child labour.
