



Report on Efforts to Prevent & Reduce the Risk of Forced & Child Labour in Supply Chains

For the financial year ended March 31, 2024

1. The steps the entity has taken during its previous financial year to prevent and reduce the risk that forced labour or child labour is used at any step of the production of goods in Canada or elsewhere by the entity or of goods imported into Canada by the entity.

In response to Canada's "Fighting Against Forced Labour and Child Labour in Supply Chains Act", this is the first reporting requirement for Stampede Leasing Ltd. (Operating as "Stampede Toyota"). In the year 2023, Stampede Toyota did not implement any measures aimed at mitigating or preventing the potential occurrence of forced or child Labour within its operations.

2. The entity's structure, activities and supply chains.

Stampede Toyota operates under the legal entity Stampede Leasing Ltd., which is structured as an incorporated private company. The company has three directors: Glen Rumpel (Dealer Principal and 75% owner), Don Hansen (CFO and 15% owner), and Adam Boyd (General Manager and 10% owner).

a) Organizational Structure:

The organizational structure of Stampede Toyota is hierarchical, with Glen Rumpel serving as the Dealer Principal at the highest position. Below him are Adam Boyd, the General Manager, and Don Hansen, the CFO.

Adam Boyd oversees the day-to-day operations of Stampede Toyota, utilizing department heads in Sales, Service, Parts, and Leasing to manage various operational aspects.

Don Hansen manages the accounting department and all financial-related decisions and activities of the dealership.

Organizational Mandate or Role:

Stampede Toyota, operating as a franchisee of Toyota Canada, serves as a dealership offering vehicle sales, leasing, and related services. The dealership's role is to effectively manage its operations in alignment with Toyota's standards and practices while delivering high-quality vehicles and services to customers.

Number of Employees:

Stampede Toyota employs between 95 and 110 employees at any given time. The workforce includes sales representatives, service technicians, administrative staff, department heads, and management personnel necessary for the dealership's smooth operation.

Partner Organizations or Membership:

Stampede Toyota is a franchisee and partner of Toyota Canada, aligning its operations closely with the standards and practices set by Toyota Canada. This partnership provides access to the latest Toyota vehicles, technologies, and marketing support, enhancing the dealership's reputation and customer offerings.

Control of Other Entities:

Stampede Toyota solely focuses on its dealership operations and does not hold interests in any other subsidiaries or controlled entities. The dealership's core business activities revolve around sales, service, leasing, and parts related to Toyota vehicles.

b) Activities

Stampede Toyota engages in the sale and distribution of Toyota vehicles, leasing options, maintenance, repairs, and the sale of automotive parts and accessories.

Approximately 60-70 million dollars worth of the dealership's total annual sales in 2023 are attributed to the sale of vehicles, parts, and accessories sourced from Toyota Motor Company. These goods comprise both domestically and internationally produced items. The remaining portion of the total annual sales comes from other revenue streams such as leasing, service, and aftermarket sales.

c) Supply Chains

Importation of Goods into Canada:

Stampede Toyota imports vehicles, parts, and accessories from Toyota Motor Company, which include goods produced and manufactured both domestically and internationally. These imported goods represent a significant portion of the dealership's total annual sales, contributing approximately 60-70 million dollars out of the 128 million dollars worth of total annual sales in 2023.

The imported goods, including a variety of Toyota vehicle models, genuine Toyota parts, and accessories, are sourced from various domestic and international locations, reflecting Toyota Motor Company's global supply chain.

Locations of Operation:

Stampede Toyota's primary location of operation is in Calgary, Alberta, Canada. Within Canada, the dealership serves customers primarily in the Calgary area but can serve customers in other regions of Alberta/Canada.

The dealership's importation activities involve sourcing goods from Toyota Motor Company's global supply chain, encompassing both domestically and internationally produced items. These imported goods contribute significantly to Stampede Toyota's operations and sales in Canada.

3. The entity's policies and due diligence processes in relation to forced labour and child labour.

Other than strictly adhering to the Alberta Employment Standards Act and the Alberta Human Rights Act, Stampede Toyota did not create or execute any new policies with relation to forced or child labour in 2023.

4. The parts of the entity's business and supply chains that carry a risk of forced labour or child labour being used and the steps it has taken to assess and manage that risk.

Stampede Toyota can be reasonably considered at low risk for forced labour and child labour, largely due to the majority of its product sales originating from Toyota Motor Company's supply chain. However, some aspects of Stampede Toyota's business, such as third-party suppliers of aftermarket accessories, automotive service parts, and promotional marketing goods, as well as service providers for physical services like catering and janitorial services, may carry some risk.

Stampede Toyota primarily acquires vehicles, parts, and accessories directly from Toyota Motor Company (TMC) and certain of its wholly owned North American subsidiaries. Stampede Toyota trusts in Toyota Motor Company's efforts to reduce the risk of child labour and forced labour within their supply chains, as outlined in TMC's compliance plan described in their report.

However, there remains some risk associated with supply chains for aftermarket accessories, parts, and tires, where Stampede Toyota may not have detailed information regarding the producers' policies or actions to eradicate child and forced Labour. Stampede Toyota is committed to addressing and mitigating these risks as part of its overall compliance efforts in the future.

5. Any measures taken to remediate any forced labour or child labour.

Other than strictly adhering to Alberta Employment Standards Act and the Alberta Human Rights Act, Stampede Toyota did not take any additional measures to remediate forced or child labour in 2023.

6. Any measures taken to remediate the loss of income to the most vulnerable families that results from any measure taken to eliminate the use of forced labour or child labour in its activities and supply chains.

Other than strictly adhering to Alberta Employment Standards Act and the Alberta Human Rights Act, Stampede Toyota did not take any additional measures to remediate the loss of income for vulnerable families as a result of measures to eliminate forced or child labour in 2023.

7. The training provided to employees on forced labour and child labour.

Stampede Toyota did not undertake any new training in 2023 to educate its staff on forced or child labour.

8. How the entity assesses its effectiveness in ensuring that forced labour and child labour are not being used in its business and supply chains.

Stampede Toyota complies with the Alberta Employment Standards Act and the Alberta Human Rights Act if considering a minor for employment, however has not accessed the policies effectiveness in ensuring that forced or child labour is not being used in the production or supply of any vehicles or parts its sells. Stampede Toyota will continue this practice and will continually monitor compliance.

9. Report Sign Off Process

Reports must include the following attestation, which must be signed by a member of the entity's governing body that has the authority to bind that entity:
