WSD Structure, Activities & Supply Chains

The Winnipeg School Division operates seventy-nine (79) public schools and five (5) administration buildings in Winnipeg. We have a centralized purchasing department that adheres to a Board approved Purchasing Policy and federal, provincial, and municipal trade agreements. The Winnipeg School Division purchases products for use in its schools and administration buildings from both Canadian and U.S. suppliers. The Winnipeg School Division does not manufacture or distribute goods for resale.

Not applicable. No risk assessment or remediation measures were implemented in relation to forced labour and child labour in activities or supply chains in the 2022-2023 fiscal year.


Training Provided to Employees on Forced Labour and Child Labour
