Our operational headquarters is located in Saskatoon, SK with branch offices located in Calgary, AB and Regina, SK. We employ over 70 office staff, while our field staff fluctuates between 170 – 250.

Wright currently operates in all Western Canadian provinces. Our experience encompasses a wide range of commercial projects and sectors: office buildings, retail, warehouses, educational buildings, healthcare, civic buildings, recreational facilities, and light industrial.

#### **Understanding Modern Slavery**

At Wright Construction Western Inc., we recognize that modern slavery can take many forms, including indentured servitude, human trafficking, forced labor, and child labor. In the construction industry, the risks are particularly high due to:

Exploitation of Migrant Workers: Vulnerable due to language barriers and legal status.

Temporary and Informal Work: Job insecurity can lead to exploitation.
