

All of our employees, partners and stakeholders are to be aware of Questor's commitment towards these values and share the same ideals.

Questor Technology Inc., incorporated in Canada under the Business Companies Act (Alberta) is an environmental emissions reduction technology company founded in 1994, with global operations. The Company is focused on clean air technologies that safely and cost effectively improve air quality, support energy efficiency and greenhouse gas emission reductions. The Company designs, manufactures and services high efficiency clean combustion systems that destroy harmful pollutants, including Methane, Hydrogen Sulfide gas, Volatile Organic Hydrocarbons, Hazardous Air Pollutants and BTEX (Benzene, Toluene, Ethylbenzene and Xylene) gases within waste gas streams at 99.99 percent efficiency. This enables its clients to meet emission regulations, reduce greenhouse gas

emissions, address community concerns and improve safety at industrial sites. The Company also has proprietary heat to power generation technology and is currently targeting new markets including landfill biogas, syngas, waste engine exhaust, geothermal and solar, cement plant waste heat in addition to a wide variety of oil and gas projects. The Company is also doing research and development on data solutions to deliver an integrated system that amalgamates all of the emission detection data available and demonstrates how Questor's clean combustion and power generation technologies can be used to help clients achieve zero emission targets.

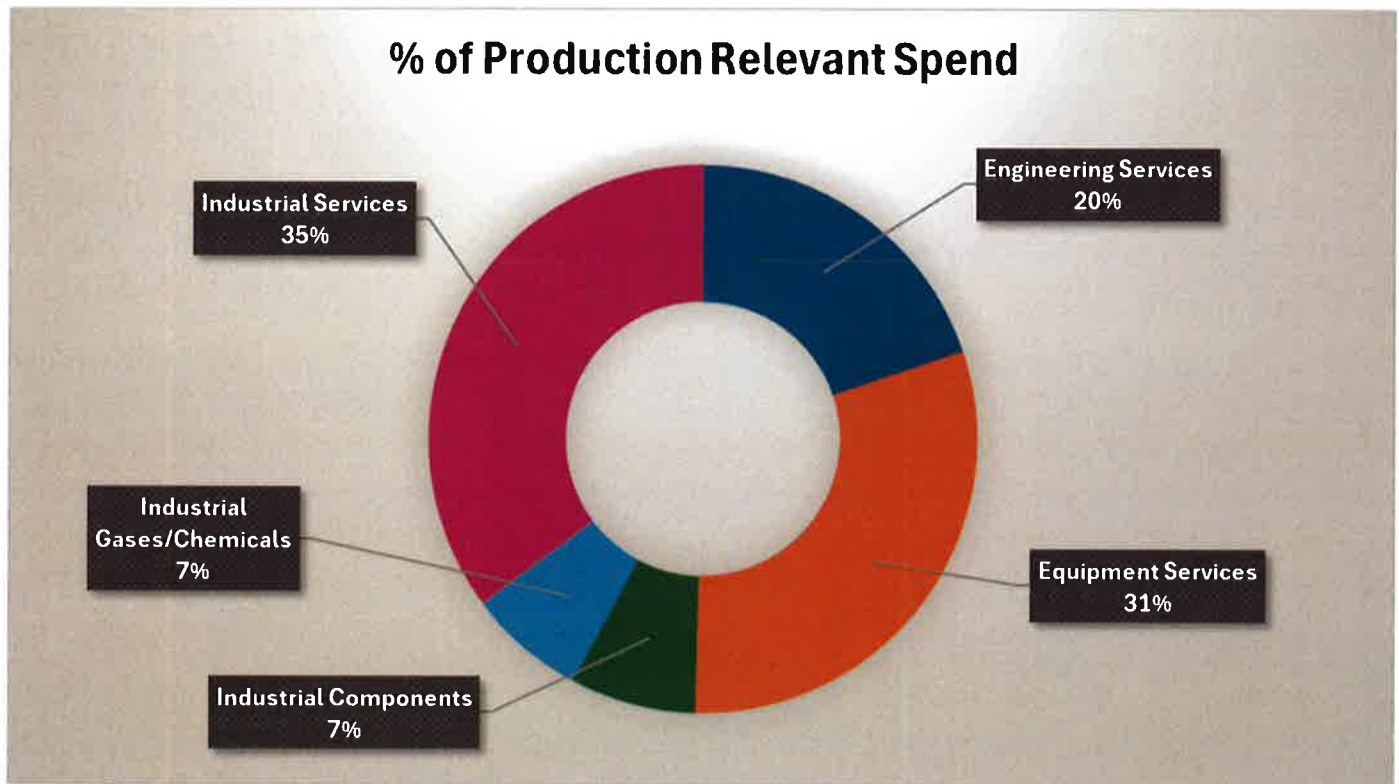
Supply Chains

In the production of new systems for sale to clients, Questor typically procures components through local distributors, outsources heavy metal fabrication and performs the final assembly with either internal or to local contractor service providers.

Identified Risks

Current

Questor's "industrial, engineering and equipment" service categories spend are deemed low risk as suppliers and personnel are local to Canada and the USA under governance of federal and provincial / state license, certifications and oversight.

Challenges existing in determining the source country profile of "industrial components" spend as visibility into manufacturer (and sub-manufacturer) details is disseminated across multiple various distribution suppliers. However, selected manufacturers are of high industry reputation usually operating in jurisdictions with anti-forced labour or human rights

standards. Questor's engagement with its key distribution suppliers has also ensued a reasonable level of confidence that those suppliers have enacted policies and oversight to address the purpose of the Act.

In fiscal year 2024, Questor did not directly procure significant amounts of "commodity material" such as steel. However, indirect providers such as Questor's industrial service suppliers have been assessed for adherence policies related to the Act and direct suppliers of such materials have pledged that 90% of their product is provided by foundries in the USA, although exact details on the source countries of the input raw commodities (iron ore, nickel, etc.) are unknown.

Future

Prospective business development plans may potentially involve service supply partnerships in higher risk locations in Asia. Further considerations and due diligence around forced and child labour will be applied prior to advancing business relationships in these geographic locations in order to manage risk and exposure.

The US-Canada tariff situation may lead industrial service suppliers to increase exposure to east Asian commodity steel and Questor will augment its monitoring activities accordingly to better understand its supplier's sources and associated risk.

Policies and due diligence processes

Embedding responsible business conduct (RBC) into policies and management systems

Questor employees are aware of RBC and supplier management policies and are empowered to proactively identify and assess human risks associated risks for on-going or future planned business relationships.

Identifying and assessing adverse impacts in operations, supply chains and business relationships

Annually, in conjunction with the Act's reporting guidelines, Questor will reassess and engage key suppliers within the previous fiscal year in reaffirming commitments to responsible business conduct and the fight against forced & child labour. Key findings from the engagement are reviewed internally in consultation with the operations and engineering functional areas.

In addition, new suppliers to Questor are requested to provide information on relevant policies and transparency into their sources of supply through a set questionnaire as a part of the supplier qualification process.

Ceasing, preventing or mitigating adverse impacts

Upon discovery of suspicion or incident, Questor employees are directed to provide the details to Questor's commercial manager for investigation and report to the chief executive officer recommendations for remediation and prevention of future risk.

Remediation measures and remediation of loss of income

Not applicable as Questor did not surface any incidence of forced or child labour in its business or supply chains.

Training

Questor conducts an annual awareness campaign with all employees and contracted staff to communicate its values statement, purpose and spirit of the Act, requirements in supplier engagement and reporting responsibilities.

Assessing effectiveness

Questor conducts ongoing screening of all suppliers, which allows us to baseline a supplier's risk profile and subsequently flag any activities in violation of Questor's policies. Any instances where corrective actions are required are recorded and escalated within the leadership team. No instances related to Questor, or its suppliers, were identified in fiscal year 2024.
