We exclusively purchase materials and equipment from Canadian suppliers to support our operations.

2. Statement of Commitment

William Kelly & Sons Plumbing Contractors (1989) Ltd. is committed to upholding ethical labor practices and ensuring that no forced labor or child labor exists within our supply chains. We understand the importance of adhering to the principles outlined in Bill S-211 and have taken steps to assess and mitigate risks in this regard.

3. Structure and Supply Chain

Our supply chain consists exclusively of Canadian-based suppliers. These suppliers are primarily located in British Columbia. Materials and equipment include:

A. Pipes and Fittings

- **Pipes:** Copper, PEX, PVC, CPVC, Galvanized, Cast Iron
- **Fittings:** Elbows, Tees, Couplings, Adapters, Bushings, Unions, Valves
- **Connectors & Joints:** Compression fittings, Threaded fittings, Soldered joints, Push-to-connect fittings (SharkBite)

B. Fixtures and Appliances

- **Sinks & Faucets:** Kitchen, Bathroom, Utility
- **Toilets & Bidets:** Residential, Commercial, Tankless
- **Showers & Bathtubs:** Tubs, Enclosures, Showerheads, Valves
- **Water Heaters:** Tank, Tankless, Gas, Electric

- **Pumps:** Sump pumps, Booster pumps, Sewage pumps

C. Tools and Equipment

- **Pipe Wrenches** (various sizes)
- **Tube Cutters** (for copper, PEX, PVC)
- **Threading Tools** (for galvanized and steel pipes)
- **Propane Torch** (for soldering copper pipes)
- **Drain Snakes & Augers**
